

PULPIT ROCK STUDENT MINISTRIES CONSENT AND RELEASE

> In consideration of participating in certain activities, endeavors, events, socials, recreational undertakings, and/or sponsored events, and for good and other valuable considerations I, the undersigned, for myself, my heirs, children, spouse (if any), administration, executors, agents, representatives, successors and assigns, do hereby release, waive, and fully discharge Pulpit Rock Church ("PRC"), and its agents, representatives, employees, elders, staff members, and all other related entities or individuals (here and after collectively referred to as "releasees"), for any and all claims, demands, losses, damages, obligations, liabilities, and cause of action of any kind or nature, at law or in equity, relating to or resulting from any injury, loss, or damage, of any kind or nature, in connection with any activity, endeavors, events, socials, recreational undertakings, and/or sponsored events involving or in any way related to the releasees, including but not limited to my participation in such activity, endeavor, event, social activity, recreational undertaking, and/or sponsored event; my release and waiver of any such claim against the releasees in this regard includes and covers any and all claims, demands, losses and damages, obligations, liabilities, and cause of action of any kind in nature, in law or in equity without limit and without the regard to the cause or causes thereof even if caused in whole or in part by any negligent act or omission of any of the releasees. I further represent and warrant to the releasees that I have fully read this document, that I understand its meaning and content, and that I am fully competent to sign for the purposes and consideration herein expressed. I further represent and warrant to the releasees that my participation in the instant activity, endeavor, event, social, recreational undertaking and/or sponsored event is purely voluntary on my part, that I do so completely of my own volition and that I am not participating on the basis of any promise, representation, or warrant by the releasees; likewise, my waiver of any and all claims, demands, losses, damages, obligations, liabilities, and causes of action of any kind in nature in law or in equity, is done so voluntarily and not on the basis of any promise, representation or warranty by the releasees.

> This release gives us permission to take your child to the nearest available medical facility and have necessary treatment administered. This is not necessary from our perspective, but from your perspective, many hospitals will not provide medical attention to a minor without parental consent. Therefore, please read the following statement and sign this consent form. All this does is to give us permission to seek whatever emergency medical attention we deem necessary.

> IN CASE OF EMERGENCY, I UNDERSTAND THAT EVERY EFFORT WILL BE MADE TO CONTACT ME. IF I CANNOT BE REACHED I HEREBY GIVE PULPIT ROCK CHURCH (PRC) THE PERMISSION TO ACT ON MY BEHALF IN SEEKING EMERGENCY TREATMENT FOR MY CHILD IN THE EVENT THAT SUCH TREATMENT IS DEEMED NECESSARY BY PRC. I GIVE PERMISSION TO THOSE ADMINISTERING EMERGENCY TREATMENT TO DO SO, USING THOSE MEASURES DEEMED NECESSARY. I ABSOLVE PRC FROM LIABILITY IN ACTING ON MY BEHALF IN THIS REGARD SO LONG AS PRC IS NOT GROSSLY NEGLIGENT. MY STUDENT, NAMED BELOW, HAS PERMISSION TO PARTICIPATE IN THE NAMED ACTIVITY ON THIS SHEET.
